FEDERATION NET COORDINATOR

We currently have 239 members covering 36 chapters in our Federation net. For our Federation, there are over 600 members listed in the GEMS net. Through the courtesy of the National Field VP for Region X, I will use the GEMS system for distributions. This will ease the burden of keeping a separate federation list and the problems of multiple mailings. This means that you must make sure that your E-Mail address is registered in the GEMS system. This also allows you to receive the weekly "Hot Line" on legislative issues which are of vital interest in retaining your benefits.

To check to see if you are registered, use the following procedure:

Go to NARFE website: www.narfe.org

- Log in
- Screen will change, on the right side under Membership Tools
- CLICK Upgrade your record
- Enter Member ID and birth date and SUBMIT
- Change your data as necessary including E-Mail address
- CLICK Update

Chapter Secretaries are about to issue new form F-7s on chapter officers for the coming year. Secretaries, please check with your new slate of officers and include the officers' E-mail address on the Form -7, if they have one.
