PROGRAM - **Mr. Randy Wallace** will be our speaker at the March meeting. Mr. Wallace is the executive Vice President of the Chattanooga Eye Bank and is active in the Lions Club. COLA - The Consumer Price Index for Urban Wage Earners and Clerical workers (CPI-W) climbed **.02** percent in January. Because of declines during the first two months (October & November) of the current measuring period, the index is still **0.8** percent lower than the 2006 third quarter average base index of 199.1. Lest anyone feel a possible decrease in his or her current annuity as the result of a negative COLA the law does not provide for a reduction in benefits in the event of deflation over a fiscal year measuring period.

proposed by-law amendment has been received. This amendment would change the Federation Convention from each year to biennially. At present, the National *NARFE* Convention is held on even years and the proposed change, if adopted, would have the Tennessee Federation Convention held on odd years.

MEMBERSHIP - Four second notices were sent to members in January by the National office and we had four reinstatements in the month. Currently, there are about 260 members in chapter #108, but less than 10 percent attend chapter meetings. It is disheartening to secure a speaker for the meeting and have only a few show up. *NARFE* is **your** organization and is the only one that represents your interests in Congress. You need to support it! Please make a special effort to attend your chapter meetings at least on occasion. This just might be the year to get some action on the bills we have been supporting. NARFE-PAC - The cover story of the March issue of *NARFE* magazine highlights the mission and urgency of *NARFE*'s Political Action Committee, *NARFE-PAC*. This has been a successful tool in furthering the interests of federal retirees and we need to give it our support. Our chapter Legislative Officer, **Don Geoffrion** also serves as our *NARFE-PAC* coordinator. He will have copies of the contribution forms at our March and succeeding meetings and hopes also to have the new lapel pins for those who wish to send in \$20 or more. Of course, you may use the form on page 20 of the March issue of *NARFE* for a direct contribution.

LEGISLATIVE NOTES - **H.R.#82**, the bill to repeal the Government Pension Offset (GPO) and Windfall Elimination Provision (WEP) now has 222 co-sponsors, including **Cong. Zach Wamp, 3<sup>rd</sup> Dist. TN**. The Senate bill, **S.#206**, has 15 co-sponsors (not yet our two Tennessee Senators). On Feb. 16, 2007, **Cong. Tom Davis, 11<sup>th</sup> Dist. VA** introduced **H.R.#1110**, which would allow civilian and military retirees and active duty military to pay their government health care premiums with pre-tax dollars. Initially this bill had 28 co-sponsors. **Cong. Wamp** surely will add his name.
