### **Tips on Recruiting Chapter Members**

It doesn't take a rocket scientist to determine that NARFE membership has been steadily dropping for several years. To make matters even worse Chapter membership is dropping even faster. In fact, our Chapter has suffered a 50% + loss of members during the past 12-15 years. As of the end of September 2022 the National membership stood at 145,844. We all would probably shutter if we knew what the membership was 12-15 years ago.

Most of the new members are opting to become "National Only" members rather than following up with a membership in their local Chapter. We are experiencing this in our Chapter. There are 8 NARFE members living in our local area that have taken this route of being a National Only member. To make matters even worse for Chapter recruitment, our current system doesn't disclose the identity of these new members living within our Chapter area. Therefore, we have no opportunity to reach out to them regarding chapter membership. NARFE headquarters admitted they are somewhat to blame by not adequately explaining the option new members have to join the local Chapter. Good news WO is taking steps to correct this problem.

With all that said we cannot sit back and let the WO do our recruitment. There are many helpful recruitment tools available to help with this recruitment effort.

Our Federation Membership Chairperson was right on when she said recently "When you recruit new members(s) it's a win win situation for everyone. We are helping NARFE to have a louder voice on Capitol Hill and we are increasing our workforce-Chapter Members that in turn can recruit new members."

I am sure many of you, after becoming a member, recruited at least one new member maybe even two or three new members. Wonder how that happened? Was it someone you worked with before retirement? I am sure it was. If we bring this theory into today's world the fresh member we recruit, who may be a generation or two behind us, recognizes the NARFE mission and how it can help them. So, what do you think could happen? This new retiree most likely will have friends they worked with, so bingo, deja vu all over again.

Let's look at or relook at some methods and tools in place that will help us recruit new members who will in turn recruit more members.

### So, How Do You Recruit a New Member?

**The NARFE website www.narfe.org/membership-resources** is a good place to start. This website has helpful recruiting tools. It provides a quick overview and a great way to let folks know what NARFE is and what NARFE does, as well as the benefits and value of NARFE membership.

The main benefit for me is advocacy. Advocacy is the reason I joined NARFE and the reason I remain a member. I also take advantage of NARFE perks. I saved over \$38 recently on a two-night stay at a Choice Hotel. Since advocacy and the perks are the main reasons that I am a NARFE member, that is usually the "selling points" that I find myself using as I recruit a new member.

For those of you who do not have access to the website, I listed a few items from the narfe.org website that you may find helpful in your recruiting efforts. Also, the following information was taken from a **sample letter and email sent to a prospect** and the famous **elevator speech**.

a. The National Active & Retired Federal Employees association (NARFE) has been protecting the earned pay, retirement, and health care benefits of federal employees, retirees, and their survivors for over100 years. As the only organization solely dedicated to the general welfare of all federal workers and retirees, our mission is to ensure a strong federal workforce and secure retirement for you and your federal colleagues. By joining NARFE, you help strengthen every message we send to Congress and you fortify our national outreach.

b. With 900 chapters across the country, NARFE is active locally as well as nationally. Our chapters provide support for the legislative agenda NARFE is pursuing in Washington, DC. Also, they get involved in community and local social activities. Here you have the opportunity to add information about our Chapter activities, what you do in our Chapter and why you continue as an active member.

c. <u>What is NARFE?</u> NARFE is the National Active and Retired Federal Employees Association. It is the <u>only</u> organization <u>solely dedicated</u> to protecting and preserving the pay and benefits of all federal workers and retirees.

d. <u>NARFE Has Two Primary Roles:</u> 1) Your Legislative Voice. In-house influential lobbyists representing NARFE advocate on Capitol Hill on behalf of the federal community; 2) Your Information Resource. NARFE provides clear information and trusted guidance on complex federal benefits issues.

## ANOTHER GREAT YEAR FOR CHAPTER ALZHEIMER'S EFFORT

Our Chapter scored another great Alzheimer's year in 2022. During the year our successful drives to raise money for NARFE Alzheimer's netted \$2,510.00. This money will be used to help NARFE and the Alzheimer's Association fund research projects. By agreement no administrative charges will be assessed. We don't know yet but the \$2,510.00 may well be the highest of any of the NARFE chapters in Tennessee.

We also had the Chapter 860 team again in the 2022 Walk2EndAlzheimer's in Cleveland. The community collected approximately \$46,000.00 for this Walk. Our total was \$3,850.00 which put us at team No. 3 out of 51 teams. In addition, 3 of our members were in the top 5 of approximately 300 walkers for this event.

Sixty-nine NARFE teams throughout the country participated and raised \$76,000.00. Our team, with \$3,850.00, was the 5th highest contributor.
